and discharge all the costs, charges and expenses incurred in or about incidental to the administration or execution of the Trust powers vested by these presents and also all outgoing taxes, rates assessments, dues, duties, levies and other taxes payable in respect thereof and the cost of meeting of ordinary repairs to any immovable property if for the time being subject to the trusts of these presents and subject there to upon trust to apply the residue of the said interest, divided and other income and at their discretion to utilize the whole or any part of the corpus of the Trust fund for charitable services in India including (i) relief to the poor, (ii) promotion of education, culture, literature, art and science and (iii) medical relief as per definition of "Charitable purposes in section 2(15) of the Income Tax Act, 1961 as the Trustees may think fit and in such manner as the Trustees may think and for one or more such public charitable purposes as aforesaid so as not to violate the provisions of Income Tax Act, 1961. Provided that the said income as well as the corpus of the Trust Fund shall be utilized only towards charitable purposes as aforesaid in India and any accumulation of income shall also be made and deemed to be made for application to such charitable purposes as aforesaid in India in accordance with the provisions of Income Tax Act, 1961.

(b) Without prejudice to the generality of the foregoing objects or purposes but subject to the aforesaid, it is declared that the Managing Trustees shall each year utilize the income of the Trust and may at their discretion at any time and from time to time utilize the Trust Fund in or towards any one of the objects of the Trust as mentioned in clause 1. The surplus and un applied portion of the said income, if any, arising in any one or more year or years shall be accumulated and / or invested in accordance with the provisions of the Income-Tax Act, 1961 as may be in force from time to time.

5) TRUSTEES:

- a) The number of the trustees including the Chairman & Managing Trustee, Managing Trustee shall be not less than three and the board may appoint one/more number of trustees/managing trustees, whenever thought fit & proper in the interest of the trust.
- b) The founder trustees, the names of whose has been mentioned above shall be the life trustees and unless they voluntarily resign or otherwise decide, shall continue to be the trustees during the term of their natural lives. In case of death, the nominated person shall be the life trustee and the above provisions will apply to her/him also. In case of non-nomination, the legal heir(only one) shall automatically be the next life trustee of the trust.
- c) A life trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.
- d) $\frac{2}{3}^{\text{rd}}$ number of trustees shall form the quorum of a meeting of the trustees.
- e) The managing trustee of the first part shall be the chairman of the board and in his absence, he may select another trustee to be the chairman of the board.

f) In case of difference of opinion among the trustees, the opinion of the majority shall prevail and in case of a tie, the chairman shall have a casting vote/opinion in addition to his opinion/vote.

g) No person being

- i) an undischarged insolvent; or
- ii) convicted of offence involving moral turpitude, or
- iii) of unsound mind; or
- iv) a minor shall be eligible to be a trustee.

h) A person shall cease to be a trustee in any of the following events:

- i) If he dies; or
- ii) If he becomes bankrupt; or
- iii) If he becomes insane or otherwise become incapable to act; or
- iv) If he resigns from his office; or
- v) If he retires from the office of the trustee

6) BOARD OF TRUSTEES:

- a) The trustees joining together shall mean and constitute a team/ group called as "Board of Trustees".
- b) The board of trustees may by a unanimous vote of all (3/3) trustees for the time being except the trustee proposed to be removed, remove any trustee, permanent or otherwise from office after finding the trustee proposed to be removed guilty of serious misconduct in relation to or concerning the trust estate or trust affairs.
- c) The board of trustees shall function and do activities as per the decisions taken in the meeting of board of trustees with majority of trustees or by a quorum of trustees as decided from time to time, whichever is more.

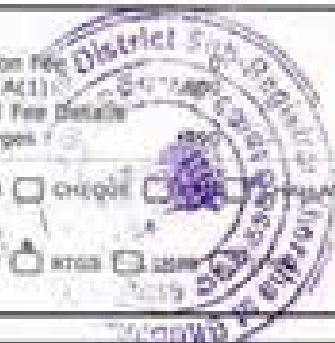
